PCSD RESOLUTION NO. 14-497

“APPOINTING NELSON P. DEVANADERA AS PCSDS EXECUTIVE DIRECTOR III EFFECTIVE FEBRUARY 1, 2014 ON A PERMANENT STATUS”

WHEREAS, R.A. 7611, otherwise known as the Strategic Environmental Plan (SEP) for Palawan, took effect on 19 June 1992 section 6 of which provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation of plans, programs and projects affecting the environment and natural resources of Palawan;

WHEREAS, Section 20 of said law empowers the PCSD to appoint the Executive Director of the Palawan Council for Sustainable Development Staff;

WHEREAS, the demise of former Executive Director Romeo B. Dorado on November 29, 2013 rendered the position of PCSDS Executive Director vacant;

WHEREAS, this Council considers the qualifications of Mr. Nelson P. Devanadera as appropriate for the position. His experiences as former Executive Director of the PCSDS and as Assistant Director (Director III) of Protected Areas and Wildlife Bureau (PAWB) will invaluablely contribute in ensuring the attainment of the goals and objectives of the SEP law and of other PCSD-mandated laws, rules and regulations;

WHEREAS, Mr. Devanadera has relinquished his position with the Department of Environment and Natural Resources as OIC Assistant Director (Director III) of the Parks and Wildlife Bureau effective January 31, 2014;

WHEREFORE, upon motion duly seconded, this Council RESOLVES, as it is hereby RESOLVED, to APPOINT Mr. Nelson P. Devanadera, as hereby HE IS APPOINTED, to the position of PCSDS Executive Director III (SG 28) on a permanent status effective February 1, 2014;

RESOLVED FINALLY, that copies of this Resolution be furnished the Office of the President, the Secretary of Natural Resources for its information and the Civil Service Commission for appropriate action.






