PCSD RESOLUTION NO. 14-512

"REQUIRING ALL THE DEALERS/MANUFACTURERS/SUPPLIERS OF CHAINSAW UNITS IN THE PROVINCE OF PALAWAN TO SUBMIT EVERY MONTH TO PCSDS LISTS OF OWNED CHAINSAW UNITS AND REPORTS ON TRANSACTIONS INVOLVING THE OWNED CHAINSAW UNITS"

WHEREAS, the PCSD in the exercise of its mandate under Section 19 paragraph 8 of Republic Act 7611 which empowers it to "adopt, amend, and rescind such rules and regulations and impose penalties therefor for the effective implementation of the SEP law" promulgated Administrative Order No. 07, series of 2012, otherwise known as the Revised Implementing Rules And Regulations of the Chainsaw Act of 2002 (RA No. 9175);

WHEREAS, the afore-cited Administrative Order requires the authorized manufacturers of chainsaw units to submit to PCSDS a quarterly (March, June, September and December) report of their transactions/activities during the quarter, which shall include the following details: number of chainsaw units manufactured, engine serial numbers of the units manufactured, number of manufactured units sold/disposed, engine serial numbers of the units sold, authorized persons to whom the units were sold with the latter's addresses and place of delivery and photocopy of their Permit to Purchase/Dealership Permit.;

 WHEREAS, the same Administrative Order also requires the authorized dealers of chainsaw units to submit to PCSDS a quarterly (March, June, September and December) report of their transactions/activities during the quarter, which shall include the following details: number of chainsaw units purchased, engine serial numbers of the units purchased, supplier or source of the chainsaw units purchased, number of units sold/disposed, engine serial numbers of the units sold, authorized persons to whom the units were sold with the latter's addresses and place of delivery and photocopy of their Permit to Purchase.

WHEREAS, the above-cited requirements are stated under the terms and conditions embodied in the Certificate of Registration and/or Dealership Permit issued by the PCSDS.

WHEREAS, in today's regular meeting, the Council was informed of the instances or cases involving chainsaw unit/s with expired Certificate of Registration and/or Dealership Permit and sold to third persons without the dealers/manufacturers/suppliers complying with their duties and obligations provided under PCSD Administrative Order No. 07, series of 2012;

WHEREAS, the Council finds it necessary to remind the dealers/manufacturers/suppliers of the above-mentioned duties and obligations and to require them to submit every month to PCSDS lists of owned chainsaw units and reports on their transactions for proper monitoring and to ensure compliance to PCSD policies;

NOW THEREFORE, upon motion duly seconded, the Council RESOLVES, as it is hereby RESOLVED requiring all dealers/manufucturers/suppliers of chainsaw units in Palawan to submit every month to PCSDS lists of owned chainsaw units and reports on their transactions for proper monitoring and to ensure compliance to PCSD policies;

RESOLVED FINALLY, that copy of this resolution be furnished the dealers/manufacturers/suppliers for their information and guidance;

RESOLVED AND ADOPTED this 28th day of October 2014 in Diliman, Quezon City, Philippines.
