PCSD RESOLUTION NO. 14-518

A RESOLUTION DIRECTING THE PALAWAN COUNCIL FOR SUSTAINABLE DEVELOPMENT STAFF TO PROVIDE TECHNICAL ASSISTANCE TO THE MUNICIPAL LOCAL GOVERNMENT UNITS IN SECURING SEP CLEARANCE AND FOR THEIR DEVELOPMENT PROGRAMS AND PROJECTS

WHEREAS, the function of implementing the provisions of the Strategic Environmental Plan (SEP) Act of Palawan otherwise known as Republic Act 7611 has been mandated to the Palawan Council for Sustainable Development (or the PCSD) which issued Administrative Order No. 06, series of 2008, as amended, providing thereof the procedures in securing clearance from PCSD in relation to the proposed projects and undertakings to be implemented in Palawan;

WHEREAS, the Municipal Government Units in partnership with the Provincial Government of Palawan will implement various infrastructure projects which will require them to secure SEP Clearance as a requirement for the issuance of Environmental Clearance Certificate (ECC) and the current limited staff and capability of the Municipal Government Units are causing difficulty in complying with the requirements of the SEP Clearance and the ECC;


