A RESOLUTION DIRECTING THE PALAWAN COUNCIL DEVELOPMENT STAFF TO REQUEST THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO INCREASE THE BUDGET ALLOCATION OF THE PALAWAN COUNCIL FOR SUSTAINABLE DEVELOPMENT FOR YEAR 2015 AND ONWARDS

WHEREAS, the Republic Act No. 7611, otherwise known as the Strategic Environmental Plan for Palawan Act's overall philosophy calls for the sustainable development of the province of Palawan through the improvement in the quality of life of its people in the present and future generations ;

WHEREAS, the function of implementing the provisions of the Strategic Environmental Plan (SEP) Act of Palawan has been mandated to the Palawan Council for Sustainable Development headed by its Chairman;

WHEREAS, the Palawan Council for Sustainable Development Staff serves as the regular professional support staff of the Council and provides the machinery to coordinate the policy and functions, implement programs, and organize such services as may be required by the Council in the exercise of its functions;

WHEREAS, pursuant to R.A. 7611, PCSD is mandated to implement Republic Act No. 9147, otherwise known as the "Wildlife Resources Conservation and Protection Act of 2001"; Republic Act No. 9175, otherwise known as the "Chainsaw Act of 2002"; Republic Act No. 9072 and other existing laws similar or complementary to R.A. 7611;

WHEREAS, for the past five years the budget level of PCSD is not enough to pursue its mandate;

NOW, THEREFORE, upon motion duly seconded, be it:

RESOLVED, AS IT IS HEREBY RESOLVED, TO DIRECT, the Palawan Council for Sustainable Development Staff, as it is hereby directed, to request the Department of Budget and Management to increase the budget allocation of the PCSD for year 2015 and onwards;

RESOLVED FINALLY, that copy of this resolution be furnished the concerned personnel of the Palawan Council for Sustainable Development Staff and the Office of the PCSD Chairman for information.
