BANUA TO THE PALAWAN COUNCIL FOR SUSTAINABLE DEVELOPMENT (PCSD) AND REQUESTING FOR HER RE-APPOINTMENT AS NCIP COMMISSIONER FOR ISLAND GROUPS AND THE REST OF VISAYAS**

WHEREAS, Section 6 of the Republic Act No. 7611, otherwise known as the "Strategic Environmental Plan (SEP) for Palawan Act, took effect on June 19, 1992 provides that the SEP shall serve as framework to guide the government agencies concerned in the formulation and implementation of plans, programs and projects affecting the environment and natural resources of Palawan;

WHEREAS, Section 16 of R.A. 7611 provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);
