**PCSD RESOLUTION NO. 04-224**

***“RESOLUTION CONFIRMING ALL THE ACTIONS TAKEN UP  
BY EXECUTIVE DIRECTOR WINSTON G. ARZAGA WITH THE  
BUSYADORS IN EL NIDO, PALAWAN”***

**WHEREAS**, Republic Act No. 9072, otherwise known as the Caves and Cave Resources Management and Protection Act, was passed into law on April 8, 2001 to carry out the declared policy of the State to “conserve, protect and manage caves and cave resources as part of the country’s natural wealth;

**WHEREAS**, Section 4 of the said Act provides that the PCSD shall be the lead implementing agency in the Province of Palawan pursuant to Republic Act No. 7611 or the Strategic Environmental Plan for Palawan;

**WHEREAS**, among others, the PCSD is empowered under Republic Act No. 9072 to issue permits for the collection and removal of guano and other cave resources;

***“PCSDS: Working together towards sustaining the future.”***

**WHEREAS**, on September 12, 2003 the PCSD passed Resolution No. 03-217 adopting the Implementing Rules and Regulations of the Republic Act No. 9072 and pursuant thereto PCSD Administrative Orders No. 08 and 08-A were adopted providing for the Implementing Rules and Regulations of Republic Act 9072 and for the issuance of permits/ for collection, extraction and removal of edible bird's nests pursuant to sec. 5.6 of PCSD Administrative Order No. 8, Series of 2003;

**WHEREAS**, pursuant to the aforementioned Administrative Orders the PCSD Executive Director entered into a memorandum of agreement with the Swiftlet Nest Gatherers Association, Inc. of El Nido for the management and protection of the caves and sustainable utilization of the cave resources and providing specific assistance to the Local Government Unit in the locality with PCSDS exercising oversight functions in the bidding of the cave resources:

**WHEREAS**, the PCSDS as part of its oversight functions has supervised the conduct of the bidding of edible birds nest and a total amount of Ten Thousand One Hundred Seventy Eight and Ninety Five Centavos (PhP 10,178.95) has been donated by the Association to Brgy. New Ibajay, Municipality of El Nido, so as not to deprive the municipality of the proceeds from the harvest of edible birds nest;


**WHEREAS**, the PCSDS believes that the above described scheme can be replicated in other municipalities which has edible birds nest;

**WHEREFORE**, on motion duly seconded, be it **RESOLVED**, as it is hereby **RESOLVED**, that the memorandum of agreement entered into by and between the Executive Director and the Swiftlet Nest Gatherers Association, Inc. represented by its President, Mr. Armando A. Abis and the subsequent actions enforcing it be confirmed, as it is hereby confirmed;

**RESOLVED FINALLY**, that copy of this resolution be furnished the association, the Municipality of El Nido for their information.
