PCSD Resolution No. 05-254

“RESOLUTION DESIGNATING THE DIRECTOR OF PROJECT OPERATION AND IMPLEMENTATION DEPARTMENT (POID) AS OFFICIAL COMPLAINANT IN CASES INVOLVING VIOLATIONS OF PCSD RULES AND REGULATIONS”

WHEREAS, PCSD is empowered under Sec. 19 par. 8 of Republic Act No. 7611 or the Strategic Environmental Plan for Palawan to “adopt, amend and rescind such rules and regulations and impose penalties therefore for the effective implementation of the SEP and other provisions of this Act;

WHEREAS, PCSD Resolution No. 03-207 as amended by PCSD Resolution No. 4-238 creates the PCSD Adjudication Board and provided for the procedures in adjudicating cases for violation of PCSD Admin Orders;

WHEREAS, no centralized authority was designated to sign and file the complaint against violators of PCSD Administrative Orders;

WHEREAS, during the 117th Regular Meeting last May 27, 2005, the Chairman raised the need to designate the official complainant and particularly recommended the Director of POID to act in behalf of PCSDS;

WHEREAS, on June 9, 2005, during the Adjudicatory Board Meeting, it was further reiterated that there is indeed a need to designate the official complainant;

WHEREFORE, on motion duly seconded, be it RESOLVED, as it is hereby RESOLVED, that the Director of POID of PCSDS be designated, as it is hereby designated as the official complainant in cases involving violations of PCSD rules and regulations, for the effective implementation of the Strategic Environmental Plan for Palawan Act;

RESOLVED FINALLY, that the Director of POID of PCSDS, be furnished copy of this resolution for information and guidance.
