PCSD Resolution No. **06-299**

“A RESOLUTION IMPLEMENTING THE LEGAL COMMITTEE’S ACTION ON THE STATUS QUO AGREEMENT CONCLUDED DURING THE MAY 04, 2006 CONSULTATION HELD IN CALAUIT, BUSUANGA, PALAWAN; ORDERING MR. FIDEL MONDRAGON COMPLIANCE THERETO AND WARNING MR. WILLIAM ENDENCIA AND OTHERS TO STOP CLEARING AREAS IN THE SAID ISLAND.

WHEREAS, the PCSD Legal Committee conducted a consultation with the Balik Calauit Movement (BCM) represented by its Chairman, Mr. Fidel Mondragon on May 4, 2006 at Calauit, Busuanga, Palawan;

WHEREAS, it was agreed during the consultation that both parties shall observe a status quo pending a compromise agreement or a decision from the Supreme Court;

WHEREAS, on June 13, 2006 reports reached our office that BCM Chairman invited families to occupy their former land areas in the island of Calauit as a result of the news that an elementary school will soon be put up in the island;

WHEREAS, the PCSD Legal Committee recommended to the Council that a resolution be made observing a status quo between the parties, ordering the BCM Chairman Mr. Fidel Mondragon compliance thereto and warning to other new migrants to the island specifically Mr. William Endencia;

WHEREFORE, on motion duly seconded, the Council resolves, as it is hereby resolved to order as it is hereby ordered to implement the Legal Committee’s action on the status quo concluded during the May 04, 2006 consultation held in Calauit, Busuanga, Palawan and ordering Mr. Fidel Mondragon compliance thereto and warning Mr. William Endencia and others to stop clearing areas in the said island;

RESOLVED FURTHER, that copies of this resolution be forwarded to the BCM thru their Chairman and the Calauit Game Preserve and Wildlife Sanctuary thru its Project Manager for their proper guidance.

ADOPTED AND APPROVED this 29th day of June 2006 in Quezon City, Philippines.
