PCSD RESOLUTION NO. 07-331

“A RESOLUTION MAINTAINING THE STATUS QUO IN SO FAR AS THE OFFICE OF THE EXECUTIVE DIRECTOR IS CONCERNED AND REITERATING THE DESIGNATION OF DEPUTY DIRECTOR ROMEO B. DORADO AS OFFICER IN-CHARGE OF THE PCSDS”

WHEREAS, in March 2006, the PCSD adopted Resolution No. 06-281 reiterating the designation of Deputy Executive Director Romeo B. Dorado as the Officer In-Charge of the PCSDS;

“PCSDS: Working together towards sustaining the future.”

WHEREAS, on February 23, 2007, during the Council's extensive deliberation of the Executive Committee's action on the appointment of Executive Director, the Council declared that its previous decision declaring a status quo has not been overturned and by majority vote of the members present reaffirmed the same;

WHEREAS, pending the resolution by the Supreme Court of the petition for review of the denial by the Civil Service Commission of the appointment of Mr. Nelson P. Devanadera as Executive Director of PCSDS, the Council deemed it necessary to maintain the status quo in so far as the Office of the Executive Director is concerned;

NOW THEREFORE, upon unanimous decision, the Council resolves, as it is hereby resolved to re-affirm the status quo in so far as the Office of the Executive Director is concerned and to reiterate the designation of Deputy Executive Director Romeo B. Dorado as Office In-Charge of the PCSDS.

RESOLVED FURTHER, that as Officer In-Charge, Mr. Dorado shall exercise full authority and perform all functions attendant to the position of the Executive Director of PCSDS;

RESOLVED FINALLY, that copy of this resolution be furnished the concerned agencies for their information and guidance.
