“ACCEPTING THE DONATION OF FIVE HUNDRED (500) SQUARE METERS PORTION OF REAL PROPERTY OF THE MUNICIPAL GOVERNMENT OF BROOKE’S POINT AND AUTHORIZING THE PCSDS EXECUTIVE DIRECTOR, NELSON P. DEVANADERA, TO SIGN THE DEED OF DONATION THEREOF”

WHEREAS, Republic Act No. 7611, otherwise known as the **Strategic Environmental Plan (SEP)** for Palawan, took effect on 19 June 1992 section 6 of which provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation of plans, programs and projects affecting the environment and natural resources of Palawan;

Mission: PCSDS as the driver of environmental conservation and inclusive development in Palawan, a biosphere reserve and science-for-sustainability site, guided by the Strategic Environmental Plan

WHEREAS, Section 16 of the same law provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);

WHEREAS, paragraph 4, Section 19 of the same law empowers the Council to “arrange, negotiate for, accept donation, grants, gifts, loans and other fundings from domestic and foreign sources to carry out the activities and purposes of the SEP”;

WHEREAS, the Municipal Government of Brooke’s Point is the absolute owner of a lot with an area of five hundred (500) square meters, a portion of land covered by Transfer Certificate of Title No. 065-2013000133 situated at Barangay Buligay, now Barangay Tubtub;



WHEREAS, in consideration of the mutual concerns of the Local Government of Brooke’s Point and the PCSD in providing basic services to the constituents of the municipality, the Municipal Government of Brooke’s Point is willing to donate the above-described parcel of land for the construction of PCSDS-DMO Building;

WHEREFORE, in view of the foregoing premises and on upon motion duly seconded, the Council resolves to accept, **AS IT IS HEREBY ACCEPTED**, the donation of five hundred (500) square meters portion of real property of the Municipal Government of Brooke’s Point and authorizing the PCSDS Executive Director, Nelson P. Devanadera, to sign the deed of donation thereof;

RESOLVED FINALLY, that copy of this Resolution be furnished the LGU of Brooke’s Point and agencies concerned for their information, guidance and reference.
