PCSD RESOLUTION NO. 96-01

A RESOLUTION INDORSING APPROVAL OF THE HOUSE BILL NO. 1483 ENTITLED "AN ACT DECLARING AS ALIENABLE AND DISPOSABLE NINE HUNDRED EIGHTY TWO HECTARES AND FIVE THOUSAND SIX HUNDRED SIXTY CENTARES OF LAND UNDER CADASTRAL SURVEY 800-D, MODULE 2, SITUATED IN BARANGAY STA. MONICA, PUERTO PRINCESA CITY, PROVINCE OF PALAWAN"

WHEREAS, House Bill No. 1483 was filed in the 10th Congress by Congressman Alfredo E. Abueg, Jr., which seeks to declare as alienable and disposable land a portion of the territory of Barangay Sta. Monica in the City of Puerto Princesa;

WHEREAS, the subject land containing a total area of 982.5660 hectares more or less, under project No.1-LC Map 203 dated December 29, 1923 is classified as timberland and therefore still part of the public domain;

WHEREAS, subject land is presently the site of government offices and residential houses, already surveyed and subdivided under cadastral survey CAD 800-D, Module 2, and was subsequently approved on November 23, 1984 by the Regional Office, but due to the failure of the Director of Lands to comply with the terms and conditions under PMD No. 3639, same was reverted to its status as public forest land;

WHEREAS, the Puerto Princesa City Sangguniang Panglunsod Res. No. 508-93 and the Province of Palawan Sangguniang Panlalawigan Res. No. 481, both resolutions favorably indorse and support the passage of the H.B. No. 10738 equivalent to H.B. No. 1483 of the 10th Congress;

NOW THEREFORE, on motion of Executive Director Arthur R. Ventura and duly seconded, be it

RESOLVED, as it is hereby resolved, to favorably indorse and support House Bill No. 1483 entitled, "AN ACT DECLARING AS ALIENABLE AND DISPOSABLE NINE HUNDRED EIGHTY TWO HECTARES AND FIVE THOUSAND SIX HUNDRED CENTARES OF LAND UNDER CADASTRAL SURVEY 800-D, MODULE 2, SITUATED IN BARANGAY STA. MONICA, PUERTO PRINCESA CITY, PROVINCE OF PALAWAN";


