BENAVENTE-VILLENA AND MADRONO P. CABRESTANTE AS AUTHORIZED SIGNATORIES WITH THE DEVELOPMENT BANK OF THE PHILIPPINES, PUERTO PRINCESA CITY BRANCH”

WHEREAS, The Palawan Council for Sustainable Development (PCSD) through the PCSD Staff in 2014 entered into a Partnership Agreement with Gruppe Angepasste Technologie (GrAT) or Center for Appropriate Technology to co-implement the Zero Carbon Resorts for Sustainable Tourism in the Philippines and in Thailand;




WHEREAS, as stipulated in the Partnership Agreement, the PCSD through the PCSDS shall immediately establish an account with any commercial or government bank and shall submit the account number to GrAT;

WHEREAS, on August 27, 2014 under PCSD Resolution No. 14-505 this Council authorized the Executive Director to open a current account at any government bank for funds intended solely for the implementation of the above-mentioned project;

WHEREAS, in compliance with the above-stated resolution a current account was established with the Development Bank of the Philippines, Puerto Princesa City Branch with account number 0635-037198-030, said account became dormant in view of inactivity for a period of six months or the absence of any deposit or withdrawal within the same period;

WHEREAS, in order to reactivate the said current account the DBP requires that this Council pass a resolution authorizing the reactivation of the same;
