PCSD RESOLUTION NO. 22

RESOLUTION DECLARING THE "TABON" BIRD AS AN ENDANGERED SPECIES AND CALLING FOR MEASURES FOR THE ADOPTION OF ITS PROTECTION AND PROPAGATION.

WHEREAS, the "Tabon" bird is one of the unique and fascinating Fauna of the Province of Palawan;

WHEREAS, this rare bird inhabits only certain parts of the Province and because of such limited habitats, its natural propagation has been slow;

WHEREAS, unrestrained gathering of "Tabon" eggs has further led to the decline of its propagation and unless promptly checked, may lead to the eventual extinction of the said bird.

NOW THEREFORE, be it resolved that:

1. The Council, in the exercise of its mandate for the protection of the indigenous wildlife of the Province of Palawan hereby declares the "Tabon" bird as an endangered species and hereby calls for the adoption of such measures for its protection

projects and the corresponding budgets with the projects, programs and policies of the SEP, as administered and implemented by the aforementioned administrative machinery, the PCSD;

WHEREAS, the PCSD, in its eighth Council meeting held on 6 February 1993, reviewed the plans, programs and projects of the Department of Tourism (DOT) in the province of Palawan as presented by its representative, Mrs. Georgina Monsod, a summary of the projects is hereto attached as Annex 1.

NOW, THEREFORE, the Palawan Council for Sustainable Development resolves that after having been briefed on the CY 1993 plans, programs and projects of the DOT in the province of Palawan, the Council concurs to said plans, programs and projects subject to the submission of the department's programs and projects to be implemented in the municipalities of Palawan.

RESOLVED FURTHER that the appropriate offices of the Commission on Audit shall be furnished copies of this resolution .
