**RESOLUTION THANKING THE OFFICIALS AND
CONSTITUENTS OF THE MUNICIPALITIES OF
CORON AND BUSUANGA**

WHEREAS, the Palawan Council for Sustainable Development (PCSD) held its 9th Council meeting last 6 February 1993 in Coron, Palawan;

WHEREAS, in line with its efforts to elicit the sentiments of the people, the Council conducted the meeting in this municipality considering that the matters that were deliberated on concern mostly the municipalities of Coron and the adjacent municipality of Busuanga;


WHEREAS, the warm welcome received by the Council members and enthusiasm as well as the active participation of the officials and constituents of these municipalities are testimonies of their commitment to the goals and objectives being pursued under the SEP;

NOW THEREFORE, the Palawan Council for Sustainable Development resolves to extend their gratitude to the officials and constituents of the Municipalities of Coron and Busuanga for

and propagation as may be necessary, including the following:


- a) Prohibiting the gathering of "Tabon" eggs;
 - b) Prohibiting the hunting or killing of the "Tabon" bird;
 - c) Enjoining the Calautit Wildlife and Bird Sanctuary in Busuanga, Palawan to immediately commence the propagation of the "Tabon" bird;
 - d) Conducting the necessary information campaign for the need to protect the "Tabon" bird.
- 2.. Pursuant to the above, the Council hereby enjoins the Sangguniang Panlalawigan and Sangguniang Bayan of the municipalities where the "Tabon" birds may still be found to immediately enact the necessary ordinances to carry out the above measures including such other steps relative thereto which they may see fit in the exercise of their legislative authority.
3. Appropriate information should likewise be made to the Parks and Wildlife Bureau for inclusion of the "Tabon" bird in their list of endangered fauna.
