PCSD RESOLUTION NO. 93-36

RESOLUTION ENJOINING THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE OF PALAWAN TO WITHHOLD THE AMOUNT CORRESPONDING TO THE FORTY PERCENT SHARE OF LOCAL GOVERNMENT UNITS FROM THE UTILIZATION AND DEVELOPMENT OF FOREST RESOURCES

WHEREAS, DENR Memorandum Circular No. 13, series of 1993 and its amendatory Memorandum Circular No. 31, series of 1993, provides for the mechanism for effective implementation of Article 390 of the Local Government Code of the Philippines (R.A. 7160) regarding the computation and automatic remittance of the shares of local government units from the utilization and development of forest resources within their area of jurisdiction;

WHEREAS, as provided for in paragraph 3 of Memorandum Circular 31, series of 1993, " xxx the PENRO's shall handle the computation indicating the corresponding shares of each city, municipality or barangay within his area of jurisdiction and shall consolidate such computed shares to be forwarded to the Finance Management Service, DENR xxx " ; and paragraph 4 of the same Circular directs the Finance Management Services to " xxx consolidate the computed shares submitted by the PENRO's and shall forward the same to the Department of Budget and Management for allocation to the Local Government Units (LGUs) concerned per pursuant to Memorandum Circular No. 97 dated 01 March 1993 issued by the Office of the President xxx ";


NOW THEREFORE, it is hereby resolved that the Palawan Council for Sustainable Development endorses the project of Bayview Holding and Realty Corporation in Lapus-Lapus at El Nido, Palawan to the Department of Environment and Natural Resources for issuance of an Environmental Compliance Certificate (ECC) provided that:

1. Measures to safeguard the nesting areas of the "nido" birds and limitation of the activities up to a certain height to protect the cliffs are embodied in the ECC.
2. The proponent complies with the Guidelines for Tourism-Oriented Establishments in Palawan formulated by the PCSD.
3. The PCSD shall monitor the compliance of conditions set forth in the ECC.

RESOLVED, FURTHER, that the DENR be provided a copy of this resolution for the issuance of an Environmental Compliance Certificate to Bayview Holding and Realty Corporation.
