PCSD RESOLUTION NO. 96-06

RESOLUTION NAMING USEC. WILLIAM RUSSEL SOBREPEÑA OF THE
DEPARTMENT OF TOURISM AS MEMBER OF THE PALAWAN COUNCIL FOR
SUSTAINABLE DEVELOPMENT REPRESENTING THE GOVERNMENT SECTOR

WHEREAS, Section 16 of Republic Act No. 7611, otherwise known as
the "Strategic Environmental Plan for Palawan Act" approved on June 19,
1992, named the Members of the Palawan Council for Sustainable Develop-
ment (PCSD), herein after referred to as the Council, including such
other members from the public or private sectors as the majority of the
Council may deem necessary;

WHEREAS, Section 6 of Republic Act No. 7611, provides that the SEP
shall serve as framework to guide the government agencies concerned in
the formulation and implementation of plans, programs and projects
affecting the environment and natural resources of Palawan;

WHEREAS, DOT and JICA entered into an implementing arrangement on
technical cooperation on March 8, 1995 where the focus of the study is
on Environmentally Sustainable Tourism Development Plan for Northern
Palawan;

WHEREAS, in the 37th PCSD meeting held on 21 July 1995, it was
proposed that the DOT be represented in the Council;

WHEREAS, the PCSD recognized the importance of the DOT representation in the Council to ensure the inclusion of the interests of Palawan in the final preparation of the master plan for an Environmentally Sustainable Tourism Development Plan for Northern Palawan;


NOW THEREFORE, upon motion of Cong. Abueg, duly seconded by all the members of the Council present;

RESOLVED, AS IT IS HEREBY RESOLVED that by virtue of Section 16 of Republic Act No. 7611 empowering the Council to name additional members to it, Usec. Russel Sobrepeña is hereby named member of the Council representing the government sector;


