PCSD Resolution No. 06-281

**“A RESOLUTION REITERATING THE DESIGNATION OF DEPUTY
EXECUTIVE DIRECTOR
ROMEO B. DORADO AS OFFICER IN CHARGE OF THE PALAWAN
COUNCIL FOR SUSTAINABLE DEVELOPMENT STAFF (PCSDS)”**

WHEREAS, Section 20, Chapter V of R.A. 7611 provides that the Executive Director of the Palawan Council for Sustainable Development Staff (PCSDS) shall be appointed by the members of the Council;

WHEREAS, the Council appointed Mr. Nelson P. Devanadera as Executive Director III of the PCSDS on temporary status effective August 13, 2005 by virtue of PCSD Resolution 05-258;

WHEREAS, on September 26, 2005, the Civil Service Commission En Banc through Resolution No.051358 granted the motion for reconsideration of the PCSD reversing its decision for the reinstatement of Mr. Winston G. Arzaga and declaring the position of Executive Director as vacant;

WHEREAS, on October 28, 2005, the Civil Service Commission disapproved the renewal of temporary appointment of Mr. Devanadera as Executive Director III (SG 28) of the PCSDS effective August 13, 2005;

WHEREAS, the PCSD filed a motion for Reconsideration/Appeal with the Civil Service Commission En Banc and further judicial appeals to the Court of Appeals;

WHEREAS, pending decision on the appeal of the PCSD with the Court of Appeals regarding the disapproved renewal of temporary appointment of Mr. Nelson P. Devanadera as Executive Director of PCSDS, Mr. Devanadera took a leave of absence;

WHEREAS, during the 123rd PCSD meeting held on November 25, 2005, Chairman Mitra stated that OIC Romeo B. Dorado will oversee the operation of the PCSDS while Mr. Nelson P. Devanadera is on a long leave;


WHEREFORE, on motion duly seconded, the council **RESOLVES**, as it is hereby **RESOLVED**; that in order to clarify the previous designation of Mr.

Dorado as PCSDS OIC and to ensure smooth and continuous office operations, the designation of Deputy Executive Director Romeo B. Dorado as the Officer in Charge of the Palawan Council for Sustainable Development Staff (PCSDS). is hereby reiterated;

RESOLVED FURTHER, that as **OFFICER IN CHARGE**, Mr. Romeo B. Dorado shall exercise full authority and perform all functions attendant to the position of Executive Director of PCSDS.






