**PCSD RESOLUTION NO. 13-484**

---

**“DIRECTING THE ENVIRONMENT AND NATURAL RESOURCES COMMITTEE TO PERFORM THE FUNCTIONS OF PALAWAN WILDLIFE MANAGEMENT COMMITTEE AND PALAWAN CAVES MANAGEMENT, PROTECTION AND CONSERVATION COMMITTEE AMENDING SECTION 4 OF PCSD ADMINISTRATIVE ORDER NO 12, SERIES OF 2011”**

WHEREAS, the PCSD in 2008 created the Palawan Wildlife and Management Committee (PWMC) as a sub-committee of Environment and Natural Resources Committee (ENR) of the PCSD to assist the Council in the implementation of R.A 9147 on the Wildlife Convention & Protection Act of 2001;

WHEREAS, in 29 July 2009 the Detailed Guidelines in the Implementation of Republic Act No. 9147 and the Joint DENR-DA-PCSD Admin Order No. 1, as may be made applicable in the Province of Palawan was approved, otherwise known as PCSD Admin Order No. 12, series of 2011, incorporating therein the creation of PWMC as Section 4 of the said Order;



WHEREAS, in the ENR meeting held on September 19, 2013 it was agreed that the function of PWMC should be performed by the ENR Committee instead of creating a sub-committee for this purpose;

WHEREAS, it was likewise agreed that the ENR Committee shall serve as the Palawan Cave Management Committee to assist the PCSD in the implementation of the Caves & Cave Resources Management & Protection Act to be incorporated in the implementing rules & regulations of the latter law;

WHEREFORE, for and in consideration of the foregoing premises and upon motion duly seconded, be it resolved as it is hereby resolved that the ENR Committee be directed as it it hereby directed to perform the following functions:

- a) Serve as the Palawan Wildlife Management Committee to perform the functions enumerated under Section 4 of PCSD Administrative Order No. 12, series of 2011;
- b) Serve as Palawan Cave Management, Conservation and Protection Committee to assist the PCSD in the implementation of Republic Act No. 9072, otherwise known as the National Caves & Cave Resources Management & Protection Act; Provided that in the performance of such function representatives of the following agencies shall be included as committee members:
  - i. National Museum
  - ii. National Historical Institute
  - iii. Department of Tourism
  - iv. Local Government Units through the League of Mayors

RESOLVED FURTHER, that copy of this resolution be furnished the above-mentioned agencies for information and guidance;

RESOLVE FINALLY, that copy of this resolution be deposited to the Office of the National Administrative Register (ONAR) at the UP Law Center, Diliman, Quezon City for publication.




