PCSD RESOLUTION NO. 14-511

“APPROVING THE APPLICATIONS FOR PERMIT TO SELL AND PERMIT TO PURCHASE FILED BY MR. ISAGANI MANTUBIG AND MS. SALLY LUNA”

WHEREAS, the PCSD in the exercise of its mandate under Section 19 paragraph 8 of Republic Act 7611 which empowers it to “adopt, amend, and rescind such rules and regulations and impose penalties therefor for the effective implementation of the SEP law” promulgated Administrative Order No. 07, series of 2012, otherwise known as the Revised Implementing Rules And Regulations of the Chainsaw Act of 2002 (RA No. 9175);

WHEREAS, the afore-cited Administrative Order requires that any person who intends to sell or purchase chainsaw unit/s in Palawan shall secure from the PCSDS a Permit to Sell or Permit to Purchase;

WHEREAS, in 2007, Mr. Isagani Mantubig was issued a PCSD Certificate of Registration NR-2007-002 over his chainsaw STIHL brand bearing Serial Number S150253979 and which registration expired in 2009;

WHEREAS, in April 2014, Mr. Mantubig applied for permit to sell the subject chainsaw unit; however, upon verification of records with the PCSDS, it was found out that Mr. Mantubig failed to renew his Certificate of Registration;

WHEREAS, the PCSDS, thru a letter dated July 16, 2014, informed Mr. Mantubig of the denial of his application for permit to sell by reason of non-renewal of the certificate of registration within the prescribed period that consequently led to his disqualification to own the subject chainsaw and to sell the same;

WHEREAS, on October 7, 2014, Mr. Mantubig and Ms. Sally Luna, a cocolumber dealer in Narra, Palawan, filed again with the PCSDS their applications for permit to sell and for permit to purchase, respectively, with the following attachments: (a) Deed of Sale dated October 09, 2014; and (b) Mayor's Permit No. 14-1539 issued in favor of Ms. Luna for the operation/use of the subject chainsaw unit;

WHEREAS, on October 13, 2014, Mr. Roque Luna for and on behalf of Ms. Sally Luna turned over the subject chainsaw unit to PCSDS for custody while the subject applications are still pending for Council's action;

WHEREAS, in today's regular meeting, the Council approved the applications for Permit to Sell and Permit to Purchase filed by Mr. Mantubig and Ms. Luna considering that Mr. Mantubig's failure to renew the Certificate of Registration was without bad faith on his part and that he has no intention to violate the laws and PCSD policies;

NOW THEREFORE, upon motion duly seconded, the Council RESOLVES, as it is hereby RESOLVED approving the applications for Permit to Sell and Permit to Purchase filed by Mr. Isagani Mantubig and Ms. Sally Luna;

RESOLVED FURTHER, that the subject chainsaw unit STIHL brand bearing Serial Number S150253979 be released to the buyer, Ms. Sally Luna, after the Certificate of Registration is renewed under her name as the new owner of the subject unit;

RESOLVED FINALLY, that copy of this resolution be furnished the applicants for their information and guidance;
