**PCSD Resolution No. 00-160**

***RESOLUTION APPROVING THE ANNUAL WORK PLAN  
(AWP) OF THE PALAWAN TROPICAL FORESTRY  
PROTECTION PROGRAMME (PTFPP) FOR CY 2000***

**WHEREAS**, the Palawan Council for Sustainable Development (PCSD) pursuant to its mandate under Republic Act 7611, otherwise known as the "Strategic Environmental Plan (SEP) for Palawan Act, is tasked to ensure the sustainable development of the province through the complementation of environmental preservation, protection and rational utilization of Palawan's natural resources;

**WHEREAS**, the PCSD implements the PTFPP within the framework of the Strategic Environmental Plan under Republic Act No. 7611 and the NIPAS Act under Republic Act No. 7586, pursuant to a Financing Memorandum ALA/PHI/37/97;

**WHEREAS**, item 2.7.4 of the Financing Memorandum provides for the creation of an Executive Steering Committee consisting among others of the PCSD members as provided for under Republic Act No. 7611, such committee shall be responsible for approving the project's annual work plan, reviewing project's progress, and providing policy direction as necessary;

**WHEREAS**, following the review and evaluation by the ESC's Executive Committee of the draft annual work and financial plan, the same was presented to the PCSD for approval;

**WHEREFORE**, on motion duly seconded, the Council resolves, as it is hereby **RESOLVED**, to approve the 2000 Annual Work Plan of the PTFPP.


**RESOLVED FINALLY**, that copies of this resolution be furnished the PTFPP Program Management Office and the EU Head of Delegation in Manila for their information.
