PCSD RESOLUTION NO. 00-172

RESOLUTION DESIGNATING MRS. ROSALINDA M. BACOSA AS REGULAR NATIONAL CO-DIRECTOR OF THE PALAWAN TROPICAL FORESTRY PROTECTION PROGRAMME (PTFPP).

WHEREAS, on 29 October 1999, the PCSD appointed Atty. Joselito C. Alisuag as the new PTFPP National Co-Director, replacing Mr. Ricardo M. Sandalo;

WHEREAS, as provided for in the Financing Memorandum, the said appointment was forwarded for concurrence by the Chief of the Delegation of the European Union who referred the matter to the Department of Foreign Affairs for advice regarding Atty. Alisuag's holding two positions;

WHEREAS, pending EU's concurrence on Atty. Alisuag's appointment, Hon. Alfredo E. Abueg, Jr., PCSD Chairman, designated Mrs. Rosalinda M. Bacosa as the interim National Co-Director; the said designation was concurred by EU in a letter dated 17 December 1999;

WHEREAS, in the exigencies of the service, the PTFPP should already have a regular national co-director.

WHEREFORE, on motion of Executive Director Joselito C. Alisuag, duly seconded, be it RESOLVED, as it is hereby RESOLVED to appoint Mrs. Rosalinda M. Bacosa, as she is hereby appointed, as the Regular National Co-Director of PTFPP effective 1 July 2000;

RESOLVED FURTHER, that Mrs. Bacosa shall be seconded pursuant to Section 9, Rule VII of the Omnibus Rules Implementing Book V of Executive Order No. 292 and Other Pertinent Civil Service Laws.

RESOLVED FINALLY, that Mrs. Bacosa, the Chief of Delegation of the European Union in Manila and the Civil Service Commission-Palawan Field Office be furnished with copies of this resolution for information and immediate compliance.
