PCSD Resolution No. 02-200

A RESOLUTION PERSUADING TELECOMMUNICATIONS ENTITIES TO CONSIDER LOCATING IN AREAS STILL UNSERVED BY PRESENT PROVIDERS

WHEREAS, it has been observed that telecommunications companies locate in areas that are already served by other companies;

WHEREFORE, upon joint motion of Rep. Abraham Kahlil B. Mitra and Vice Governor David A. Ponce de Leon, duly seconded by Atty. Joselito C. Alisuag, the Council resolves, as it is hereby resolved, to persuade

telecommunications entities to consider areas which have not been served by the present providers.
