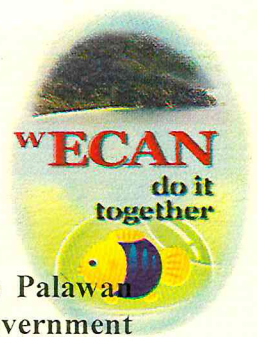


WHEREAS, the invaluable support rendered by Mayor Edward S. Hagedorn shows his commitment to the undertakings of the Council;
