**“A RESOLUTION REACTIVATING PCSD RESOLUTION NO. 01-185, “ A
RESOLUTION CREATING THE POSITION OF DEPUTY EXECUTIVE DIRECTOR
AND DESIGNATING MR. ROMEO B. DORADO TO THE POSITION AS DEPUTY
EXECUTIVE DIRECTOR OF THE PALAWAN COUNCIL FOR SUSTAINABLE
DEVELOPMENT STAFF (PCSDS)”**

WHEREAS, pursuant to PCSD Resolution No. 01-185, adopted and promulgated on August 31, 2001, which created the position of Deputy Executive Director and designated Mr. Romeo B. Dorado as acting Deputy Executive Director;

“PCSDS: Working together towards sustaining the future.”

WHEREAS, for the ensuing years, the said position has been put into inactive status while the PCSDS faces much greater tasks and responsibilities to promote and encourage natural resource management, conservation and protection program to benefit the Province of Palawan and to effectively and efficiently implement environmental plans, programs and projects for the future of Palawan in consonance with the main strategy provided for by the SEP law;

WHEREAS, the Executive Director needs the assistance of a Deputy Executive Director who will assist the former in the general supervision and administration of the Council Staff;

WHEREAS, the Council with all the members present unanimously approved the reactivation of PCSD Resolution No. 01-185;

WHEREFORE, on motion duly seconded, the council resolves, as it is hereby **RESOLVED**, to reactivate, as it is hereby **REACTIVATED**, the position of Deputy Executive Director of the PCSDS;

RESOLVED FURTHER, that MR. ROMEO B. DORADO be ordered, as hereby he is ordered to assume the position as **DEPUTY EXECUTIVE DIRECTOR** of the PCSDS;

RESOLVED FURTHERMORE, that the PCSD should make representation with the Department of Budget and Management for the inclusion of the position to the regular plantilla of the PCSDS;

RESOLVED FINALLY, that copies of this resolution be furnished the Department of Budget and Management for their information and guidance.
