WHEREAS, during the 186<sup>th</sup> PCSD meeting the technical support Staff of the Council recommended to the PCSD for appropriate action twenty five (25) duly evaluated projects for issuance of SEP Clearance and PCSD Accreditation, respectively, as presented in Annex "A";

The Council **RESOLVED** as it is hereby **RESOLVED** to approve the issuance of SEP Clearance/Accreditation for the aforementioned projects as shown in Annex "A" hereof and made integral part of this resolution;
