WHEREAS, the PCSD was duly constituted on 15 August 1992 with ten members mandated by law as provided for in the section referred to in the preceding paragraph;

WHEREAS, the mandated members are empowered to choose additional members from the public and private sectors to sit in the Council and as of date, representatives from the following organizations/offices were designated: Integrated Bar of the Philippines - Palawan Chapter, Western Command - AFP, tribal communities, non-governmental organizations, and the Sangguniang Panlalawigan of Palawan;


