FOR CY 1993 PURSUANT TO SECTION 6 OF R.A. 7611


WHEREAS, R.A. 7611, otherwise known as the Strategic Environmental Plan (SEP) for Palawan Act, took effect on June 19, 1992 and Section 16 of said Act provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);

WHEREAS, Section 6 of R.A. 7611 also provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation and implementation of plans, programs and projects affecting the environment and natural resources of Palawan;

NOW THEREFORE, the Palawan Council for Sustainable Development hereby resolves to set a conference with the Honorable Secretary Angel C. Alcala of the Department of Environment and Natural Resources to discuss the relationship of DENR and the PCSD specifically with regard to the commercial log ban issue and the operation of the Calauit Wildlife Sanctuary.


