**A RESOLUTION APPOINTING ATTY. JOSELITO C. ALISUAG

WHEREAS, PCSDS Executive Director **ARTHUR R. VENTURA** has tendered his irrevocable resignation effective August 15, 1998;

WHEREAS, under Section 20 of Republic Act 7611, the PCSDS Executive Director is to be appointed by the members of the Council;

WHEREAS, **ATTY. JOSELITO C. ALISUAG** has been nominated by the Office of the President to fill in the position;

NOW, THEREFORE, upon unanimous motion of the members present, **RESOLVED** as hereby it is **RESOLVED**, to appoint **ATTY. JOSELITO C. ALISUAG** as Executive Director of the Palawan Council for Sustainable Development Staff, to take effect on 16 August 1998, with compensation at the rate the position carries in the Plantilla of Personnel of the PCSDS, and with all the rights, privileges and responsibilities thereunto appertaining;
