AUTHORIZING THE PCSDS EXECUTIVE DIRECTOR NELSON P. DEVANADERA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH LAND BANK OF THE PHILIPPINES TO AVAIL OF THE LATTER'S E-PAYMENT FACILITY KNOWN AS LANDBANK LINK.BIZPORTAL

WHEREAS, Republic Act No. 7611, otherwise known as the Strategic Environmental Plan (SEP) for Palawan, took effect on 19 June 1992 section 6 of which provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation of plans, programs and projects affecting the environment and natural resources of Palawan;

WHEREAS, Section 16 of the same law provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);

Mission: PCSDS as the driver of environmental conservation and inclusive development in Palawan, a biosphere reserve and science-for-sustainability site, guided by the Strategic Environmental Plan

WHEREFORE, in consideration of the foregoing premises and on motion duly seconded, the Council resolves to authorize Mr. Nelson P. Devanadera to enter into and sign the Memorandum of Agreement with Land Bank of the Philippines to avail of the latter's E-payment facility known as LANDBANK Link.BizPortal;
