PCSD RESOLUTION NO. 19-672

“AUTHORIZING THE PCSDS EXECUTIVE DIRECTOR NELSON P. DEVANADERA TO SIGN THE DEED OF DONATION BETWEEN THE MUNICIPAL GOVERNMENT OF ROXAS, PALAWAN AND THE PALAWAN COUNCIL FOR SUSTAINABLE DEVELOPMENT OVER THE 2,000 SQUARE METERS OF LOT IN SO. BAGTO, BARANGAY SAN NICOLAS, ROXAS, PALAWAN AND ALL PERTINENT DOCUMENTS RELATIVE THERETO, SUBJECT TO APPLICABLE LAWS, RULES AND REGULATIONS”

WHEREAS, Republic Act No. 7611, otherwise known as the Strategic Environmental Plan (SEP) for Palawan, took effect on 19 June 1992 section 6 of which provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation of plans, programs and projects affecting the environment and natural resources of Palawan;

Vision: Palawan, an innovative and dynamic global center of sustainable development

Mission: PCSDS as the driver of environmental conservation and inclusive development in Palawan, a biosphere reserve and science-for-sustainability site, guided by the Strategic Environmental Plan

WHEREAS, Section 16 of the same law provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);

WHEREAS, Section 34 of the Amended Rules and Regulations implementing the SEP for Palawan states that matters of day-to-day operations and all those pertaining to the internal operations shall be left to the discretion or judgment of the Executive Director, unless otherwise provided by the Council and the rules and regulations.;

WHEREAS, the Municipal Government of Roxas, Palawan, is currently constructing its new Municipal Hall Building located at Barangay II, Roxas, Palawan which necessitates the demolition of the PCSD building in the said premises;

WHEREAS, the PCSD interposes no objection to the demolition of the said PCSD Building provided that the proposed demolition be subject to the appropriate clearance from Commission on Audit (COA) to be secured by the Municipal Government of Roxas;

WHEREAS, the Municipal Government of Roxas, through Mayor Maria Angela V. Sabando, informed the PCSDS in a letter dated February 18, 2019 of its intent to donate a certain parcel of land in favor of the PCSD for the construction of the new PCSD building;

WHEREAS, the Municipal Government of Roxas is the claimant/possessor of a certain parcel of land located at Sitio Bagto, Barangay San Nicolas, Roxas, Palawan, portion of which will be donated for the proposed construction of the new PCSD Building;

WHEREFORE, in consideration of the foregoing premises and on motion duly seconded, the Council resolves to authorize Mr. Nelson P. Devanadera to sign the deed of donation between the municipal government of Roxas, Palawan and the Palawan Council for Sustainable Development over the 2,000 square meters of lot in So. Bagto, Barangay San Nicolas, Roxas, Palawan and all pertinent documents relative thereto, subject to applicable laws, rules and regulations;


