PCSD RESOLUTION NO. 19-690

AUTHORIZING THE PCSDS EXECUTIVE DIRECTOR NELSON P. DEVANADERA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH LAND BANK OF THE PHILIPPINES TO AVAIL OF THE LATTER'S OVER-THE-COUNTER PAYMENT SERVICES

WHEREAS, Republic Act No. 7611, otherwise known as the Strategic Environmental Plan (SEP) for Palawan, took effect on 19 June 1992 section 6 of which provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation of plans, programs and projects affecting the environment and natural resources of Palawan;

WHEREAS, Section 16 of the same law provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);

Vision: Palawan, an innovative and dynamic global center of sustainable development

Mission: PCSDS as the driver of environmental conservation and inclusive development in Palawan, a biosphere reserve and science-for-sustainability site, guided by the Strategic Environmental Plan

WHEREAS, Section 34 of the Amended Rules and Regulations implementing the SEP for Palawan states that matters of day-to-day operations and all those pertaining to the internal operations shall be left to the discretion or judgment of the Executive Director, unless otherwise provided by the Council and the rules and regulations.;

WHEREAS, the PCSDS is currently undertaking the streamlining of its facilities and services to provide fast and efficient alternative payment collection services to its clientele;

WHEREAS, the Land Bank of the Philippines operates the LANDBANK Link.BizPortal, an e-Payment facility that allows clients to pay for products and services via the Internet from both the government and private institutions/sectors, for which a MOA has been entered into between the PCSD and LBP;

WHEREAS, PCSDS also intends to avail of the over-the-counter facility to availability of other means of transmitting payments to ensure a more efficient and faster payment transaction with its clientele;

WHEREAS, the terms and conditions of the LANDBANK Link.Bizportal embodied in the Memorandum of Agreement entered into by PCSDS under PCSD Resolution No. 19-669 does not include over-the-counter payment;

WHEREFORE, in consideration of the foregoing premises and on motion duly seconded, the Council resolves to authorize Mr. Nelson P. Devanadera to enter into and sign the Memorandum of Agreement with Land Bank of the Philippines to avail of the latter's over-the-counter payment facility;


